PetroWorth Announces Private Placement Financing

Calgary, Alberta – PetroWorth Resources Inc. (CNQ: PTWR) (Frankfurt: T3F) announced today it is conducting a non-brokered private placement financing to raise up to \$2,000,000. The financing will be raised through a combination of the following offerings:

- Up to 500,000 to 1,500,000 Units @\$1.25 per unit consisting of one Flow Through Share and one Common Share
- Up to \$500,000 @ \$0.50 per Common Share
- Up to \$1,500,000 @ \$0.65 per Flow Through Share.

A commission of 10% may be paid to registrants with respect to all or a portion of the financing by way of cash.

The financing is expected to close on or about February 21, 2007.

PetroWorth Resources Inc. is a junior oil and gas exploration company with extensive onshore properties in Eastern Canada. The Company has acquired 100% working interests in almost one million acres in nine separate exploration permits on Prince Edward Island, Nova Scotia and New Brunswick. The strategy of the company is to conduct aggressive exploration drilling programs on these permitted properties, both in-house and through advantageous farm-in arrangements.
